# **BOOTCAMP COURSE STRUCTURE**

#### Module 1: GENERAL INTRODUCTION TO INTERNATIONAL INVESTMENT LAW

The first module provides you with a general introduction to international arbitration. This module covers all the basic principles and rules of mainly commercial arbitration, which historically served as a role model for investment arbitration. You will discuss and analyze, for example, the arbitration agreement, the appointment of arbitrators, procedural issues, applicable law and enforcement of arbitral awards.

#### Module 2: SUBSTANTIVE STANDARDS OF PROTECTION

The second module will focus on the protection of foreign investments under public international law. The relevant sources relate to treaties (i.e. bilateral and multilateral investment protection treaties) and customary international law. One important aspect of this module is treaty interpretation based on the Vienna Convention on the Law of Treaties.

#### Module 3: DISPUTE SETTLEMENT IN MODERN INTERNATIONAL INVESTMENT LAW

The third module will illuminate the traditions of the Investor-State Dispute Settlement and provide an outlook on Intra-EU Investment Arbitration (CJEU's Achmea decision, C-284/16) and its repercussions.

#### Module 4: ECONOMIC SECURITY MEASURES AND THEIR IMPACT ON INVESTMENT LAW

This module explores how evolving national and regional economic security measures are reshaping the landscape of international investment law. It examines investment screening mechanisms in jurisdictions like the EU, USA, and India, and the growing emphasis on state sovereignty and regulatory space. Key topics include national security exceptions in BITs, recent arbitration jurisprudence, and CELIS-led policy innovations. Participants will analyze real-world disputes and learn how economic security concerns increasingly influence investor rights and ISDS frameworks.

#### Module 5: CAREERS IN INTERNATIONAL INVESTMENT LAW
